# WORLD SERVICE CONFERENCE: Our Spiritual Principles in Action

Throughout this year's World Service Conference (WSC), members explored ways in which the 2014 Conference theme affects worldwide Al-Anon. All of the WSC sessions illustrated the theme—from the Policy discussions on memorial contributions and Al-Anon members who are also members of A.A., to the Board of Trustees' Big Question regarding how Al-Anon will look in the year 2051, after 100 years of Al-Anon Family Groups. The talks by the International Representative and the outgoing Conference members did so as well.

#### Vicky A., the Panel 52 Delegate from Minnesota South, shared the following:

"My first Area Assembly was a painful experience! I sat in the back of the room and watched the attendees energetically disagree and differ with enthusiasm. I couldn't stand it and promised myself I will never be one of those Group Representatives, they are crazy! The same night, I saw the same crazy people sitting in a hot tub laughing, hugging, and caring deeply about one another. I'd come to understand this was my first exposure to our 'Spiritual Principles in Action' in service.

"In the house I grew up in, the rule was, he who talked loudest won. Everybody was expected to have an opinion and support it. Of course, then we would not speak to one another for years.

"I learned and stayed in service which resulted in me serving as Delegate. I could not have anticipated what I would learn in this position and was not prepared to discover the parts in my soul that still needed healing. Nor did I consider that healing those deep wounds would come from serving as Delegate, but it did! I felt the overwhelming unconditional love and trust immediately upon being elected. Subsequently, I faced my deep-rooted beliefs that I was unlovable and not good enough.

"As Delegate, I walked through experiences, faced fears, and learned that when I felt vulnerable I did not have to flee. The problems were different but the solutions were the same and were found in our spiritual principles. I saw this when there was contention over an issue; the Chair pushed the pause button, thereby protecting our group unity. I was reminded that we all come here for a very good reason and my only real job is to love and be loved. Unconditional love was present every day of every World Service Conference if my heart was open to it. As in every other Al-Anon service experience, I received so much more than I gave.

"I came to my first World Service Conference to serve my Area Al-Anon family; I am leaving my final World Service Conference having served my worldwide Al-Anon family.


"I'm proud of us. We did the Higher Power's work to keep our fellowship vital and present for others who have also been affected by the family disease of alcoholism."

#### **Alateen Outreach to Professionals**

- We have been working with counselors in the school system. In some cases, they have been reaching out to Al-Anon; in others, we have been personally contacting them and developing relationships. In Boulder, our District 8 Alateen
- Coordinator found a counselor in their school district who is friendly to Al-Anon and Alateen, and the Coordinator is assisting by providing Alateen members, parents, and other members for school district-wide counselor meetings. We
- have discovered that many school counselors do not know about Al-Anon and Alateen. We congratulate and thank
- District 8 for this success. Our District 12 Coordinator assisted with setting up a meeting to support a school for atrisk teens. We believe it is important to speak directly with the school counselors; the friendly ones may then help
- facilitate school communication and work with you to negotiate the school policies. Hopefully we will be able to train more members in face-to-face meetings. Our Area Public Outreach Coordinator is setting up mock panels to improve
- Al-Anon outreach to professionals. We hope to learn from this and do the same for Alateen.

Each year, outgoing Delegates are invited to share on the Conference theme. The following are excerpts from some of the sharings. #### Heard at the 2014 World Service Conference

"My service journey has been guided by my Higher Power. Sometimes, I volunteered for a position that allowed me to practice a skill that I wanted to develop, knowing that you would still love me if I 'did it wrong.' Other times, I took a position that frightened me. This gave me the opportunity to walk through uncomfortable feelings, something I have found is necessary to my growth.

"At the World Service Conference, I feel connected to Al-Anon's pioneers. They started a conversation and shared with us what worked for them to keep the conversation going. The Conference procedures seem to have sprouted from years of experience; they foster an environment where many ideas are available. I learn because I get to hear different perspectives. I deepen my understanding of the Traditions and Concepts by applying them to the issues that come before us. When it comes time for a vote, we are able to make an informed decision. We keep coming back, keep having the conversation, and keep loving each other, even if we don't always like each other."

"Walking into my first World Service Conference, I felt like a newcomer again. I was in awe. I knew I didn't belong. I looked around the room and all of you were much more accomplished than I was. What was I doing here? Did my Area make a mistake electing me? How would I ever be able to speak? Finally, losing my fear of criticism, and feeling worthy enough to contribute to the largest group conscience of the worldwide fellowship of Al-Anon, I went to the microphone. I felt the love of a Higher Power; I was an equal. There was that connection again; it was truly our 'spiritual principles in action' for me.

"When I was elected Delegate, I was told that it would change my life. Indeed it has changed my life, but more importantly, it has changed my heart. Serving as Delegate, I am presented with many opportunities and challenges daily to demonstrate those spiritual principles. I try to do this by giving back the love, respect, and energy that is practiced here.

"I have learned it is not about my opinion or defending my right to be right. It is about listening to the minority voice and not being afraid. It is about displaying trust, flexibility, tolerance, accountability, responsibility, and unity. It's about living those spiritual principles and putting them into action in all areas of my life."

#### My Home Group

Rotation is one of the primary practices of my home group – we sign up to chair for a month at a time – or work it out with a friend if we will be gone part of the time. We each want to give that time and energy to our group so we all will hear sharings that move us along in recovery. We know we will grow ourselves if we spend the bit of time it takes to prepare a topic or ask someone else to share with us.

We take our turn as group officers; most of us have served as Group Representative, recently or maybe twenty years ago. We have taken care of the literature, chaired our Public Outreach committee or helped with projects to carry the message, and we've taken our turn as treasurer. We don't rotate the treasurer's job as often as the rest because of the hassle of changing signatures at the bank. But most of us have taken our turn sometime since we have been coming.

We each have taken the literature bag home with us and brought it back the next week since we aren't able to store our literature at the library where we meet. We usually take our turn to chair the monthly business meeting when we are chairing the regular meeting for the month.

Most of us have been Alateen Group Sponsors or are certified as Al-Anon Members In Alateen Service (AMIAS) even though we no longer have an Alateen group meeting at the same time. We want to be available to help with Alateen in any way we can and we always explain Alateen in both our regular and our newcomer meetings.

We also chair the newcomer meeting before our regular meeting on a rotation of two persons each meeting. We are blessed to have newcomers almost every week and offer them the three-meeting pattern developed by the St. Louis Intergroup.

Most weeks, when one of us shares why having a home group is important, having the opportunity to grow in service that the home group offers us is one of the benefits mentioned.

## Alateen Sponsor Workshop

With the assistance of the District 12 Alateen Coordinator, an Alateen Group Sponsor Training Workshop was held in Cedar Park. We started with getting to know each other. Why were we here? Four attendees were there for their second training session, recommitting for another year to their registered Alateen groups. The others were curious.

Six of our attendees were there for their first time ever at an Alateen Group Sponsor training event. They sat in amazement as we discussed how we are not above the law, and as Alateen Group Sponsors there are laws with which we must abide. They learned about permission forms and medical release forms. They learned a few new acronyms and who their trusted servants are.

Yes, it isn't as easy as it was back in the "old days" to become an Alateen Group Sponsor. But there are those who feel that the rewards far outweigh the requirements. The rewards can come when we least expect it, and my heart is filled with gratitude.

For the 10 people who elected to spend a Saturday learning about becoming an Al-Anon Member Involved in Alateen Service (AMIAS), I hope that they have at least increased awareness of our process. I hope that they are willing to do public outreach within their own communities to publicize the need for Alateen Group Sponsors and for Al-Anon members to bring their kids to meetings.

### Bermuda Joining the North Carolina Area

"How did the North Carolina Area have the honor of acquiring Bermuda to be part of our Area? Members of Bermuda Al-Anon were instrumental in starting the process of Bermuda joining North Carolina. At that time, the A.A. groups in Bermuda were part of the A.A. North Carolina Area, and the Al-Anons were interested in doing the same. In mid-1983, Bermuda requested to be part of the North Carolina Area. Research was done and the information was put before the 1983 Fall Assembly to bring it back to their groups. The groups in both countries were polled to see if they were in favor of this move, and they were. At the 1984 Spring Assembly, the motion was presented to the NC Area Assembly to proceed with the request to the World Service Conference for Bermuda Al-Anon to join NC Al-Anon. The motion was approved by the Assembly. The Delegate at that time presented the request to the 1985 World Service Conference for approval. The World Service Conference approved the request. After Bermuda joined NC, the official name was changed in the fall of 1985 to North Carolina/Bermuda. Bermuda's DRs and GRs have been well represented at our AWSC meeting, assemblies and conventions. Bermuda AFG has pot luck dinners with speakers, raffles, and an annual beach party to fund their DR's travel expenses. Once in each Delegate's three-year term, the Delegate visits Bermuda. The relationship between Bermuda and North Carolina has continued to grow and strengthen. Our relationship is very amicable and rewarding.

#### New tools available to help, when conflict creeps into Al-Anon meetings and service

The last thing we want when we walk through the doors of Al-Anon is more conflict to add to what we already have at home! Even with the best of intentions, personal differences can lead to tension and discord, getting in the way of recovery.

# Anonymity —A Spiritual Principle

Tradition 12: Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities.

It may seem strange that the principle of anonymity is called a spiritual principle. But the concept is that we are a fellowship of equals. There are no "rock stars" in Al-Anon. There is no "spokesperson" for Al-Anon. We're all struggling against the effects of alcoholism in our lives.

So how does that play out for the Webmaster? I have to make sure anything posted maintains the anonymity of any Al-Anon or A.A. member. Some criteria I have to watch for are: 1) any company name mentioned (like in an e-mail address) and point out that it could imply endorsement, and 2) I have to ensure that the first and last name is not used in the e-mail address.

We can be as anonymous as we wish, or not anonymous, WITHIN the fellowship. So we can use our last names in meetings (as long as they are not being taped). We can even put our full names on fliers, as long as they are only shared within meetings.

But the Web site is considered "public media." This will change when I get the "Members Only" section of the Web site operational. But for now I have to send back any flier that has personally identifiable info on it.

How does this play out for your Internet use? If you are a trusted servant and send e-mails in that official capacity, it is suggested you use an anonymous e-mail address for that service. Any of the Web-based e-mail services will set up a name as long as it isn't taken. And we have many e-mail addresses that we can setup for an event at the "event@ga-al-anon.org" e-mail address.

Also, on social media such as Facebook, Instagram, Pinterest, and Twitter, I can't mention that I am a member of Al-Anon. I can "like" different recovery-related pages because anybody in the public can "like" something without saying that they are members. But I can't start a public group for members of my Al-Anon friends.

So, the bottom line is, within the fellowship I can be as anonymous as I want. But on the Web, I have to maintain my anonymity and that of others that I know are in the program.

How Al-Anon Works is available as an audio book too (eA-22). What great company on that drive to work! These are available through your electronic media provider.

#### Always learning in service

This is the second article I have written for the First Quarter edition of the *Newsletter*. My first one didn't quite make the cut. Our Newsletter Editor does a great job; she publishes only the best for our Kentucky Area. In doing so, she has all articles proofed by our proofreaders. One of our proofreaders questioned the quotations from Conference Approved Literature (CAL), included in my article, which prompted our Editor to contact the World Service Office (WSO) to see if permission is needed. Lo and behold, permission *is* needed. In following the policies in the *Al-Anon/Alateen Service Manual* (P-24/27), WSO cannot grant permission to use substantial reprints of CAL in Area Newsletters, but can grant permission to use limited excerpts from CAL after receiving the completed "Request for Permission to Reprint" form. The WSO then processes this form.

My first response to learning this new information was to say to myself, "I should have known better as the Literature/ Forum Coordinator." Prior to Al-Anon, I would be extremely hard on myself for making such a mistake. In fact, I didn't think I should ever make mistakes. Today, I can simply learn from my mistake and move on. I know I will make more mistakes, and that is okay. I am grateful for my growth in recovery and in service.

#### **Letter to Long-timers in Al-Anon**

We older members of Al-Anon play a very important role in our groups. By our attitudes and general bearing, we can prove to the new member that Al-Anon really works. Whether we like it or not, newcomers will judge Al-Anon by what it has done for us. If we have achieved even a degree of serenity, tolerance, and understanding, newer members will aim to acquire these qualities also. On the other hand, if we try to dominate and do not give the newer members a chance to develop, we are stunting our groups and keeping newcomers away. From a place on the sidelines, old-timers can give the group purpose and continuity but not management – unless asked to fill a special function. We are always willing to help where we can but the active leadership of the group should be in newer hands. Our passive but inspirational leadership is much more important than the active direction of a group.

If at one time we held the active leadership of our group, it may be particularly hard to let go. It is so easy to believe that because we have been in Al-Anon for years, we must be qualified to tell others what to do, but our "actions speak louder than words." When taking an inventory, we long-time members need to constantly remind ourselves of this point and ask ourselves if, for some personal reason (thoughtlessness, egotism, a desire to dominate), we are still telling others what to do and what not to do.

I have to learn this lesson myself and want to pass it on to all you other long-timers. We have now become the backbone of Al-Anon and can be the real "proof of the pudding."


Treatment Facilities Outreach Project materials now available on the Members' Web site

Area Group Records Coordinator Report

To date, we only have four groups that are on the "No Mail" status list. Everyone has done a great job of sending me group changes. I believe, for the first time in years we had no returns from the last *Pipeline* that was sent out! Way to go Texas West! I want to continue to stress the importance of accurate group information. We want to be sure that:

- Newcomers find meetings easily
- There is reliable information to callers on the WSO toll-free meeting line
- Returned mail is reduced as it is a great financial expense for the fellowship
- I am able to contact someone about the group meetings

From time to time, I receive e-mails from WSO informing me that someone received meeting information from them and when they arrived at the meeting, no one showed up. District Representatives (DRs), I want to encourage you to review the Al-Anon and Alateen Group information with each of your Group Representatives (GRs) and make sure meeting information is correct. Groups no longer have to mail the Al-Anon Registration/Group Records Change Form (GR-1) to WSO. DRs and GRs can either mail me the form or send me an e-mail with the group changes.

DRs are now able to view the Al-Anon and Alateen group records for their districts in the WSO database using the WSO Online Group Records application. It is a password-protected Web site that requires the same login and password you use for e-Communities. If you do not know how to access this information, please let me know and I will walk you through it.

#### Attention Public Outreach Coordinators: New Service Manual expands Public Outreach

The "Digest of Al-Anon and Alateen Policies" section of the 2014-2017 Al-Anon/Alateen Service Manual (P-24/27) has increased and is substantially revised. The World Service Conference Approved motions during this three-year period are now available



in print and on-line on the WSO Members' Web site.

The new topics that help trusted servants explain our public outreach policies are:

- Philosophy and spiritual principles that guide our public outreach activities, e.g., attraction rather than promotion.
- Value of local members' contact with professionals and the media in their communities.
- Different roles and responsibilities of members, groups, and the WSO.
- Anonymity in the media and face-to-face at local events.
- Use of technology.

"Supporting Group Growth" in the "Al-Anon/Alateen Groups at Work" section of the *Service Manual* also has been updated to reflect the updates in the Policy Digest section.

# District focuses on correctional facilities

Highlights of our "We" accomplishments are:

- 1. An introductory meeting for parents held at a juvenile center is supported by 12 members who rotate in groups of three to conduct the newcomer Al-Anon meetings. A group nearby donates *Parents' Newcomer Packets* (K-24) and other literature. The center has agreed to help buy Al-Anon materials.
- 2. Three speaker panels with three members per panel to give a monthly Al-Anon presentation at a minimum security half-way housing center for clients expected to be released in 90 days.
- Provided a speaker and two Al-Anon Contacts\* who write letters to inmates at a meeting for female inmates.
- 4. A member supported two visits to the state Civil Correction Drug Court to speak to the clients' families and encourage them to attend Al-Anon meetings.

\*Note: Please contact the WSO for information about Al-Anon's Inmate Correspondence Service. This service provides an Al-Anon Contact who shares about the Al-Anon program with an inmate. Al-Anon Contacts do not disclose their full names, telephone numbers, or personal e-mail addresses.


